Re General Data Protection Regulation (GDPR)

Data Protection law is changing and we want to keep you up to date with the steps Wessex Cardiology is taking in relation to this.

On 25 May 2018, the General Data Protection Regulation, known as GDPR, comes into effect. GDPR imposes additional obligations on organisations and gives you extra rights around how your data is used.

We want you to know that Wessex Cardiology respects the information we hold on you and that we take the security of your information very seriously. The practice database is fully GDPR compliant.

We have recently published a new Privacy Notice to give you more information on the data we hold on you, what we do with that data, who we share your data with and your new rights under GDPR.

The changes mean that you will need to give permission for us to contact you by email, leave messages on home answer machines, mobile phones and speak to your spouse.
